The Urban Diplomat

Alfred Fraijo gets back to his roots bridging business and community development in East $\ensuremath{\mathsf{LA}}$

East Los Angeles is known as one of Southern California's most impoverished communities. Real estate EASL LA-Augues is known as one or southern Cainforma's most improverished communities. Real estate attorney Alfred Fraijo, however, is proof that there's more to East LA than the poverty statistics, sound bites, and stereotypes. Fraijo personally understands the deep character, culture, and conviction within the community.

A native of the Boyle Heights neighborhood, he grew up surrounded by violence but was shaped more by his community's assets than its deficits. His father, a truck driver, and his mother, a Mexican immigrant, taught him ovoting-class values like hard works, scholarship, and service. These values led to his earning a bachedor's degree from Harvard University and a law degree from Loyola Marymount University. Now a partner in the Los Angles office of Sheppary, Mullin, Richter & Hampton LIP, where he leads the firm's real estate, land use, and natural resources practice group, Praijo has dedicated his career to improving Boyle Heights and other undenserved communities in the area. His instrument for doing so—commercial real estate—is surprising, yet effective.

It seems that you've succeeded, not in spite of where you're from, but because of it. How did your childhood in East LA

My mother immigrated to the United States with my grandmother, who was a farmin worker, and my father was first-generation Mexican share as settled in Boyle Heights. It sa probominantly Mexican-American community that has a really interesting immigrant history. For several generations, it was the second-largest Jewish community the United States. The Prockety, multi the came predominantly Japanese-American, and then, which will be the limit of States. In french that because it was an important element of my updringing. How did you decide that real estate would be a good vehicle

in the San Prancisco Bay Area that was doing a lot of work
around environmental justice. That exposed me be real estate development and land use. I found a nexus
between community development, social justice, real estate, and the environmental field. Environmental
justice is an important component of social justice in regards to some of the issues that are challenging
for our community. The perceived status of properties in the urban core as commanded properties for
potentially contaminated properties, for instance, actually hinders the reuse of underutilized parcels.

That's what I' nu currently focused on in my work as a real estate attorney: I take underutilized properties
and find new uses for them that are beneficial and catalytic to communities that are underserved.

Can you offer an example that illustrates the kind of "arban diplomacy" you practice?

In southcentral Los Angeles there was a heavy industrial site that was vacant for many years. Along with my client, it worked an a redevelopment plan that required a policie-private partnership. What we ended up being able to do as a result of that partnership was create a new commercial center that has an array of uses—restaurant, retail, and commercial—in an area that was wastly underserved. Obviously, that project generate there jobs because it took a none-veant, 30-acree praced and transformed it into a thriving, commercial center with shops and amenities and places for the community to gather.
